Dependent Verification Worksheet Instructions

Sections C and D of the Dependent Verification Worksheet requests information about the student and parent(s) 2024 Federal Tax Return data. To provide this to Illinois State University you will need to consent to the use of the FUTURE Act Direct Data Exchange (FA-DDX) tool on the FAFSA and have a successful transfer of your information **OR** request a 2024 IRS Tax Return Transcript from IRS.gov **OR** submit a physically signed copy of your 2024 Federal 1040 Tax Return and schedules 1, 2, 3 (if applicable). Parents that did not file a 2024 Federal Tax Return must provide a Verification of Non-Filing Letter from the IRS and copies of all W2's (if applicable). Students that did not file a 2024 Federal Tax Return but earned income in 2024 must provide copies of all 2024 W2's. Below you will find directions on how to consent to the use of the FUTURE Act Direct Data Exchange tool, and how to request an IRS Tax Transcript or Verification of Non-Filing Letter.

Using the FUTURE Act Direct Data Exchange tool

Student – Access your FAFSA at www.studentaid.gov and log into your account. Once logged in, click on the option to "Make FAFSA Corrections" (this will take you to your completed FAFSA information). In your FAFSA you consented to have your Federal Tax Information (FTI) obtained automatically from the IRS and provided on your FAFSA application. If your 2024 Federal Taxes were filed and your information was retrieved, then you were not asked to manually provide FTI data and can mark the first option in box D above.

Parent(s) – Access your parent invite from your personal email address and click 'Log In' to access the parent contributor section of your student's FAFSA. In your parent contributor section of your students FAFSA you consented to have your Federal Tax Information (FTI) obtained automatically from the IRS and provided on your student's FAFSA application. If your 2024 Federal Taxes were filed and your information was retrieved, then you were not asked to manually provide FTI data and can mark the first option in box C above.

Requesting an IRS Tax Return Transcript

To obtain a 2024 Tax Return Transcript go to www.irs.gov and click "Get your tax records and transcripts". Then choose "Sign in to your online account" or "Get transcript by mail". You will need to sign in with your ID.me account. To verify your identity with ID.me, you will need to provide a photo of an identity document such as a driver's license, state ID, or passport. You will also need to take a selfie with a smartphone or a computer with a webcam. The transcript displays online upon successful completion of the IRS's two-step authentication. Requests can also be made by telephone at (800) 908-9946 or by completing a 4506-T form that can be mailed or faxed to the IRS. Please be sure to request the "IRS Tax Return Transcript" and **NOT** an "IRS Account Transcript". The transcripts requested by "Get Transcript by Mail", Phone, or 4506-T form are generally received within 10 business days from the IRS's receipt of your request.

Verification of Non-Filing Letter

To obtain a 2024 Verification of Non-filing letter go to www.irs.gov and click "Get your tax records and transcripts". Then choose "Sign in to your online account" or "Get transcript by mail". You will need to sign in with your ID.me account. To verify your identity with ID.me, you will need to provide a photo of an identity document such as a driver's license, state ID, or passport. You will also need to take a selfie with a smartphone or a computer with a webcam. The transcript displays online upon successful completion of the IRS's two-step authentication. If you already have an account established, you can log in to access a Verification of Non-filing letter. Requests can also be made by completing a 4506-T form that can be mailed or faxed to the IRS. Verification of Non-filing letters requested by 4506-T form are generally received within 10 business days from the IRS's receipt of your request.
